7th congress integrated mediation

One hears the recommendation to utilize mediation constantly. But what do we want to achieve?

Visions are examples, which describe the ideal picture especially when the law is involved. Courts, associations and institutions try to use mediation to establish something. One should ask, "Do we have a common and committed goal"? How will mediation help achieve the final result? What is the profile of the mediator in the future? Is it enough just to be certified?

This conference will be the platform where EVERYONE has their speaker's corner. We will examine facts, exchange experiences and introduce new and unknown methods to use in mediation.

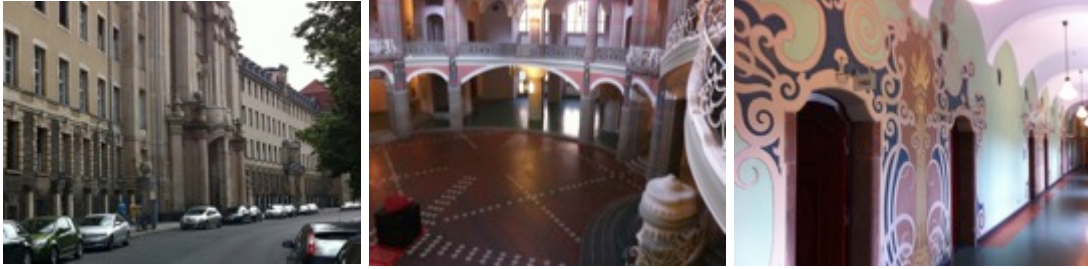
